and Assigns forever. And the mortgagor does itself, its successors Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said mortgagee, its successors

Successors and Assigns, from and against the mortgagor, its Executors, Administrators and Assigns and every person whomsoever lawfully claiming or to claim the same or any part thereof.

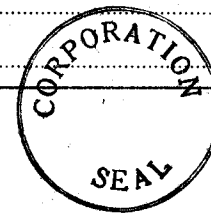
