well and truly indebted to The South Carolina National Bank

in the full and just sum of Five Thousand Dollars  
(\$-----) Dollars, to be paid as follows: \$250.00 six months from date;  
\$250.00 twelve months from date; \$250.00 eighteen months from date and the remainder two years  
from date, with the privilege to anticipate the whole amount due one year from date,

with interest thereon from date until paid at the rate of five per centum per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

BEGINNING at an iron pin on Buncombe Street at the corner of the lot of now or  
formerly Mary Beattie Mathews and runs thence with the line of that lot 150.3 feet, more or  
less to a nine foot alley; thence along and with said alley 58.8 feet, more or less, to the  
line of the R. H. Stewart lot; thence with the line of that lot 74.2 feet; thence continuing  
along the line of that lot 72 feet to Buncombe street; thence along Buncombe Street 73 feet,  
more or less, to the beginning corner.

All of the above distances as given in the description are approximately correct
