Whereas, I the said U. L. Hudson

the said mortgagor, Have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said mortgagee:

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, on the Rutherford Road, adjoining lands of Miller, Stokes and Wynn, and being the same lot of land conveyed to J. M. Davis by R. L. Wynn by DEED recorded in Vol. 182, page 251 and conveyed to me by E. Inman, Master, having the following metes and bounds, to wit:-
