All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being shown and delineated on Plat made by W. D. Neves, Engineer, February 11, 1921, recorded in Plat Book E at Page 279, and having the following metes and bounds, to-wit:

BEGINNING at a point at the Northeast intersection of Buncombe Street and Brooks Avenue, and running thence with the Eastern side of Brooks Avenue, N. 28-20 E. 131.4 feet to center of line fence between said property and lot formerly owned by Mrs. M. O. Earle; thence with the line of said Lot S. 60-52 E. 96.6 feet to corner of Lot formerly owned by Beacham; thence with the rear line of said Lot S. 36-28 W. to an iron pin at the Southwest corner of said Lot; thence with the line of said Lot S. 61-30 E. 10 feet to an iron pin; thence S. 36 W. 61.2 feet to an iron pin; thence S. 47-30 W. 50 feet to an iron pin on Buncombe Street; thence with the Northern side of Buncombe Street, N. 33-53 W. 81.9 feet to the beginning corner.
