called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Forty-three Hundred Fifty and no/100** Dollars (\$ **4,350.00** ), with interest from date at the rate of **four and one-half** per centum ( **4 1/2** %) per annum until paid, said principal and interest being payable at the office of **Liberty Life Insurance Company** in **Greenville, S. C.**, or at such other place as the holder of the note may designate in writing, in monthly installments of **Twenty-four and 19/100** Dollars (\$ **24.19** ), commencing on the first day of **September**, 19 **43**, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **August**, 19 **68**.

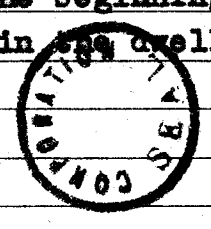
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

**All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the West side of Old Augusta Road, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 19 on plats of Augusta Road Ranches, made by Dalten & Neves, Engineers, April 1941, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book L, at pages 52 and 53, and also Plat Book M, at page 47, and having, according to said plats, and a recent survey made by R. E. Dalton, July 21, 1943, the following metes and bounds, to-wit:**

**BEGINNING at an iron pin on the West side of Old Augusta Road at joint front corner of Lots No. 19 and 20, and running thence with the line of Lot No. 20, S. 89-47 W. 198.8 feet to an iron pin on the East side of a 15 foot alley; thence with the East side of said alley, N. 0-13 W. 50 feet to an iron pin at the Southeast corner of the intersection of said 15 foot alley and DeOley Avenue; thence with the South side of DeOley Avenue, N. 89-47 E. 178.4 feet to an iron pin; thence continuing with DeOley Avenue on a curved line in a Southeasterly direction to an iron pin on the West side of Old Augusta Road (the chord of which is S. 42-36 E. 33.7 feet); thence along the West side of Old Augusta Road, S. 5-0 W. 25.8 feet to the beginning corner.**
