Beginning at an iron pin on East side of Emma Street at the Northwest corner lot No. 8 and  
running thence along line of said lot 8 N 85-30 E. 150 ft. to iron pin; thence N 2-30 W. 50  
feet to iron pin in line of lot No. 10-A; thence along line of said lot No. 10-A S 85-30 W.  
150 ft. to iron pin on East side of Emma Street; thence along said East side of Emma Street  
S 2-30 E. 50 feet to the beginning corner.
