(\$ 4,500.00) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of

T-7 and T-8; thence along the joint line of said lots, S. 19-30 W. 114 feet to an iron pin, joint corner of said lots on the north side of East Croft street; thence along the line of said East Croft street, N. 70-30 W. 50 feet to the beginning corner.
