All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in Ward I of the City of Greenville, being situate on the East side of David Street, and more particularly described according to Survey and Plat of Pickell & Pickell, Engineers, dated October 25, 1944, as follows:
