MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Nancy C. Hudgens

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of THREE THOUSAND AND NO/100 DOLLARS (\$ 3000.00), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Greenville Township, on the western side of Grove Road, near the City of Greenville, being shown as Lot No. 18 of Block M on plat of property of O. P. Mills made by H. Olin Jones in May, 1914, recorded in Plat Book C at page 176 and described as follows:

BEGINNING at a stake on the western side of Grove Road 66.5 feet north from Elm Street at corner of Lot No. 19, and running thence with line of said lot N. 53-00 W. 167.2 feet to a stake on line of lot No. 20; thence with line of said lot, N. 36-37 E. 68 feet to a stake, corner of Lot No. 17; thence with line of said lot, S. 51-41 E. 152.9 feet to a stake on Grove Road; thence with western side of Grove Road S. 24-06 W. 66 feet to the beginning corner. Being the same property conveyed to Nancy C. Hudgens by Charles F. Mayes by deed of even date recorded herewith.
