TO ALL WHOM THESE PRESENTS MAY CONCERN: I. Daisy Lee Potts,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Paris Mountain Township, on the Southwestern side of Orlando Avenue, known and designated as Lot No. 80 on plat of Paris-Piney Park, recorded in the R.M.C. Office for Greenville County in Plat Book "H" at page 19, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Orlando Avenue, corner of Lot No. 79, and running thence with line of said lot, S. 34-30 W. 150 feet to an iron pin; thence S. 55-30 E. 50 feet to an iron pin, corner of Lot No. 81; thence with line of said lot, N. 34-30 E. 150 feet to an iron pin on Orlando Avenue; thence with the Southwestern side of Orlando Avenue, N. 55-30 W. 50 feet to the point of beginning.
