SEND GREETING:

WHEREAS, I, the said Kenneth O. Keith

in and by my certain promissory note in writing, of even date with these presents am well and truly indebted to CITIZENS LUMBER COMPANY, A CORPORATION

in the full and just sum of EIGHTEEN HUNDRED AND NO/100-(\$1800.00) Dollars to be paid: In monthly installments of \$18.00 each on the 29th day of each month hereafter; said payments to be applied first to interest and then to principal, until paid in full.

with interest thereon from date at the rate of six (6%) per cent. per annum, to be computed semi-annually and paid monthly until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten (10%) per cent of the amount due thereon

besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That the said Mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee, according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor in hand well and truly paid by the said Mortgagee, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain and release unto the said Mortgagee, and his successors Heirs and Assigns, forever, all and singular that certain piece, parcel, lot or tract of land situate, lying and being in Paris Mountain Township, Greenville County, State aforesaid, on the South-

ern side of the Greenville-Pickens Road, about 5 1/2 miles from the Greenville County Courthouse, containing 2 1/2 acres, more or less, and described as follows:

BEGINNING at a stake on the Southern side of the Greenville -Pickens Road, corner of property of Dill Cantrell, and running thence with the line of said property S. 35-30 W. 29.87 chains to an iron pin by Poplar on the bank of a branch, and running thence with said branch in a Westerly direction 1.30 chains, more or less, to a stake corner of property of Olive R. Keith; thence with line of said property N. 35-30 E. 29.86 chains, more or less, to a stake on the Greenville-Pickens Road; thence with the Southern side of said road, S. 66 E. 57.75 feet to beginning corner, being the remaining portion of the property conveyed to the mortgagor by J. J. Barrett by deed dated February, 1944, recorded in Book of Deeds 260 at page 391.
