Tract No. 1:

All that piece, parcel or lot of land, situate, lying and being on the corner of East Curtis St. and Church St., in the town of Simpsonville, in Austin Township, Greenville County, State of South Carolina, being bounded on the north by lot now or formerly owned by First Baptist Church, on the east by lot now or formerly owned by W. J. McKinney estate, on the south by East Curtis Street, and on the west by Church Street, and having the following metes and bounds:

BEGINNING at the corner of East Curtis St. and Church St., and running thence along the northern side of East Curtis St., N. 68 1/2 E 85 ft. to corner of lot now or formerly owned by W. J. McKinney estate; thence along line of said lot in a northerly direction 185 ft., more or less, to point in line of lot now or formerly owned by First Baptist Church; thence along line of said lot in a westerly direction 85 ft., more or less, to pin on Church Street; thence along the eastern side of Church Street; S. 17 1/2 E. 179.4 ft. to the beginning corner.

Tract No. 2:

All that piece, parcel or lot of land, situate, lying and being in the Town of Simpsonville, State of South Carolina, on the north side of Curtis Street, being that portion of the lot bought by G. E. Mayfield from W. J. McKinney on February 24, 1913, and having the following metes and bounds, to-wit:

BEGINNING at the southeast corner of lot formerly owned by G. E. Mayfield, and running 20 ft. in an easterly direction along Curtis St.; thence in a northerly direction to a stone in center of old Georgia Road; thence in a westerly direction 15 ft. to lot formerly owned by G. E. Mayfield; thence along said lot formerly owned by Mayfield, south to the beginning corner on Curtis Street.
