MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, S. L. Wilbanks, Mrs. S. L. Wilbanks and Lois E. Wilbanks (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-seven Hundred Fifty and No/100 DOLLARS (\$3750.00), with interest thereon from date at the rate of six per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Northern side of Beck Avenue, near the City of Greenville, being shown as Lot No. 109 on Plat of Augusta Road Ranches, made by Dalton & Neves in April, 1941, recorded in Plat Book L at Page 253, and described as follows:

BEGINNING at a stake on the Northern side of Beck Avenue, 382.3 feet West from Augusta Road at corner of Lot No. 110, and running thence with the line of said lot, N. 00-13 W. 335.6 feet to a stake; thence S. 72-28 W. 62.8 feet to a stake at corner of Lot No. 108; thence with the line of said lot, S. 00-13 E. 316.9 feet to a stake on Beck Avenue; thence with the Northern side of Beck Avenue, N. 89-47 E. 60 feet to the beginning corner; being the same property conveyed to the mortgagors by Traxler Real Estate Company by deed dated August 11, 1944, recorded in Book of Deeds 266 at Page 296.
