MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, HENRY O. GAULT

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, In Greenville Township, on the southern side of Circle Street, near the City of Greenville, being shown as Lot No. 22 on plat of Hillside Heights made by R. E. Dalton, Engineer, in September, 1923, recorded in Plat Book "F" at page 100, and being more particularly described as follows:
