in the full and just sum of Four Hundred (\$400.00) Dollars

with interest thereon from date at the rate of six per centum per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the Eastern side of Burns Street in the City of Greenville, being shown as Lot No. 5 on Plat of property of Jim Howard, made by P. B. Wilson, Jr., December 31, 1945, (being a subdivision of Lot No. 10 of the property of R. J. Williams made by R.E. Dalton in November, 1924, recorded in Plat Book F at Page 263), and described as follows:

BEGINNING at a stake on the Eastern side of Burns Street, 176.1 feet North from Woodfin Avenue, at corner of Lot No. 4, and running thence with the line of said lot, S. 88-30 E. 112.7 feet to a stake; thence N. 3-46 W. 40.8 feet to a stake; thence N. 88-47 W. 104.6 feet to a stake on Burns Street; thence with the Eastern side of Burns Street, S. 8-05 W. 40.4 feet to the beginning corner.
