~~all the above lots of land situated on the North side of~~ Willow Spring Drive Southwest of the Laurens Road near the City of Greenville, being known and designated as Lots Nos. 9 and 10, Block A, of a Plat of East Highlands Estates prepared by Dalton & Neves, Engineers, April, 1940, and recorded in Plat Book K, pages 35 and 36 and being more particularly described as follows:

BEGINNING at an iron pin on the North side of Willow Spring Drive at the joint corners of Lots Nos. 10 and 11, and running thence with the North side of said Willow Spring Drive N. 66-30 E. 172.2 feet to an iron pin at the joint corners of Lots 8 and 9; thence with the joint line of Lots Nos. 8 and 9, N. 53-00 W. 297.7 feet to an iron pin on the Southeastern side of a five foot strip reserved for public utilities; thence along the Southeast side of said reserved strip S. 37-00 W. 150 feet to an iron pin at the joint rear corners of Lots Nos. 10 and 11; thence with the joint line of Lots Nos. 10 and 11 S. 53-00 E. 213.1 feet to an iron pin on the North side of Willow Spring Drive, the beginning corner.
