MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, George E. Page

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, known as Lot No. 23 in Subdivision of the Earle Lands, as shown on Plat recorded in Plat Book F at Page 81, and having the following courses and distances according to said Plat:

"BEGINNING at a pin on Harris settlement Road where it intersects with Easley Bridge Road, and running thence N. 22 W. 158 feet to line of Lot No. 22; thence with the line of said lot, in a Southwesterly direction, 150 feet to corner of Lot No. 28; thence S. 22 -E. 61 feet to Harris Settlement Road; thence with Harris Settlement Road, S. 75 E. 189 feet to the beginning corner. Less, however, a strip 10 feet in width taken from the western side of said lot for street purposes."
