MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Vernelle J. Bouchillon

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-Three Hundred & No/100 DOLLARS (\$ 3300.00), with interest thereon from date at the rate of five & one-half / (5 1/2) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All ~~that~~ certain piece, parcel or lot<sup>s</sup> of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, at the Northwestern corner of Welcome Avenue and Mary Street near the City of Greenville, shown as Lots No. 117 on Map No. 2 of Camilla Park made by W. J. Riddle in December, 1943, recorded in Plat Book M at Page 85 and described as follows:

"BEGINNING at a stake on the Northwestern corner of Welcome Avenue and Mary Street and running thence with the Northern side of Welcome Avenue, S. 59-30 W. 150 feet to a stake at corner of Lot No. 86; thence with the lines of Lots Nos. 86, 87 and 88, N. 6-42 W. 205.5 feet to a stake at corner of Lot No. 116; thence with the line of said Lot, S. 87-52 E. 187 feet to a stake on Mary Street; thence with the Western side of Mary Street, S. 2-08 W. 76 feet to a stake; thence continuing with Mary Street, S. 35-18 W. 53.6 feet to the beginning corner."
