TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Gladys Hughes Watson

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Western side of Brockman Avenue, near the City of Greenville, being Lot No. 8 as shown on plat of property of Vivian Q. Guion, recorded in Plat Book C at Page 131, and an adjoining triangular portion of Lot No. 24 as shown on plat of Sans Souci Villa, recorded in Plat Book A at Page 510 and described as follows:
