MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Harriet King Geer

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, containing 3.18 acres, more or less, and being more particularly described as follows:

"BEGINNING at an iron pin at the Eastern paving line of Highway No. 29 at corner of property now or formerly belonging to F. E. Edwards and running thence along the East side of paving line, N. 24-20 E. 486 feet to an iron pin; thence S. 65-30 E. 290 feet to an iron pipe; thence S. 36-50 E. 250 feet to iron pipe; thence S. 79-10 W. 380.9 feet to iron pipe; thence S. 77-10 W. 249.7 feet to the beginning corner."
