MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, J. Cranston Gray and Nell J. Gray

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seven Thousand Two Hundred Fifty & No/100 DOLLARS (\$ 7250.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the West side of Lanneau Drive, being known and designated as Lot No. 50 as shown on plat of Lanneau Drive, Highlands, made by Dalton & Neves, Engineers, August, 1937, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book D at Pages 288 and 289, and having according to said plat, and a more recent survey entitled property of John F. Drake made by Dalton & Neves, Engineers, March, 1939, the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the West side of Lanneau Drive, joint corner of Lots Nos. 49 and 50, which iron pin is 243.7 feet North of the Northwest intersection of Lanneau Drive and East Faris Road, and running thence along the joint line of said lots, N. 79-49 W. 159.9 feet to an iron pin, joint rear corner of Lots 49 and 50; thence N.10-11 E. 50 feet to an iron pin, joint rear corner of Lots Nos. 50 and 51; thence along the joint line of said lots, S. 59-49 E. 153.7 feet to an iron pin on the West side of Lanneau Drive; joint corner of Lots Nos. 50 and 51; thence along the West side of Lanneau Drive, S. 3-13 W. 50.4 feet to the point of beginning."

Said premises being the same conveyed to the mortgagors by deed of A. D. Lewis and Evelyn Putman Lewis to be recorded herewith.
