MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, J. C. Lee

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as Lot No. 9 of the property of G. M. Cox as shown on Plat made by W. J. Riddle, and having the following metes and bounds:

"BEGINNING at the corner of Lot No. 10 on a Street(now Arch Street) 75 feet North of another Street; thence with said Arch Street, N. 26-35 E. 97.7 feet; thence S. 33-45 W. 235 feet to corner of Lot No. 8; thence with the line of Lots Nos. 8 and 10, S. 56-15 E. 85 feet; thence with the line of Lot No. 10, N. 33-45 E. 192.4 feet to the beginning corner."
