L. Bruce and C.O. Berry made by S. C. Moon, and recorded in the R.M.C. Office for Greenville County in Plat Book J, Page 54, and having the following notes and bounds, to-wit:-

BEGINNING at an iron pin on the North side of Greenville-Greer Highway in the middle of Southern line of Lot No. 12, at corner of Lot conveyed to Perry E. Lindsey, and running thence along line of said Lindsey lot in a Northwesterly direction 200 feet to an iron pin in line of Lot No. 21; thence along line of said Lot No. 21 in a Northeasterly direction 100 feet to an iron pin in center of rear line of Lot No. 14; thence a new line through Lot No. 14 in a South-easterly direction 200 feet to an iron pin on the North side of Greenville-Greer Highway; thence along said North side of Greenville-Greer Highway in a Southwesterly direction 100 feet to the beginning corner.
