"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the West side of Fifth Avenue in Judson Mills No. 1 Village, being known and designated as Let No. 62 as shown on a plat of Section No.1 of Judson Mills Village made by Dalton and Neves, Engineers, in August 1939, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book K at Pages 11 and 12, and having, according to said plat, the following metes and bounds, to-wit:-

"BEGINNING at an iron pipe on the West side of Fifth Avenue, 215 feet South of the Southwest corner of the intersection of Fifth Avenue and Heatherly Drive, and running thence with Fifth Avenue, S. 4-30 W. 70 feet to an iron pipe, joint front corner of Lots Nos. 62 and 63; thence with the line of Lot No. 63, N. 85-30 W. 90 feet to an iron pipe; joint rear corner of Lots Nos. 72 and 73; thence with the line of Lot No. 73, N. 4-30 E. 70 feet to an iron pipe, joint corner of Lots Nos. 61, 62, 73 and 74; thence with the line of Lot No. 61, S. 85-30 E. 90 feet to the beginning corner."
