MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, L. E. Greer
.....(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eleven Hundred and No/100 - - - - - DOLLARS (\$1,100.00.....), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, about two and one-half miles Southeast of the Greenville County

Court House in the subdivision known as Fallis Annex said tract being known as Lot No. 5 according to plat of W. D. Neves, Engineer, March 1913, recorded in the R.M.C. Office for Greenville County in Plat Book C at Page 101, and having the following metes and bounds, to-wit:-

"BEGINNING at a stake on the Western side of Bradley Street, 500 feet from the corner of Earle Drive, and running thence S. 64-30 W. 320 feet to a stake; thence S 24 E. 100 feet to a stake; thence N. 64-30 E. 320 feet to a stake on Bradley Street; thence with Bradley Street, N. 24 W. 100 feet to the beginning corner."

Said premises being the same conveyed to the mortgagor by Jonah E. Taylor by deed dated May 3, 1945, recorded in Volume 275 at Page 118.
