MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: R. W. Miller and Aurelia D. Miller,

----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the north side of Kim Street, and being known and designated as Lot No. 13 of Block 'O' of a subdivision of the property of O. P. Mills, as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book F at Page 299, and having the following metes and bounds, to-wit:-
