MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Richard R. Ollis

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of THIRTY-SEVEN HUNDRED FIFTY & No/100 DOLLARS (\$ 3750.00), with interest thereon from date at the rate of four per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is here by acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northern side of McCrary Street, near the City of Greenville, and being shown as lot No. 34 on plat of Elizabeth ~~Heights~~ ^{Streets}, made by C. M. Furman, Jr., in April 1925, and recorded in the RMC Office in Plat Book "F" at page 298, and having according to said plat the following metes and bounds, to-wit:-

BEGINNING at a stake on the Northern side of McCrary Street, 100 feet west from Green Street at corner of lot No. 35, and running thence with the line of lot No. 35 N. 13-45 E. 150 feet to stake in line of lot 37; thence with the line of said lot N. 76-15 W. 50 feet to iron pin, corner of lot No. 33; thence with the line of lot No. 33 S. 13-45 W. 150 feet to stake on McCrary Street; thence with the Northern side of McCrary Street S. 76-15 E. 50 feet to the point of beginning. Said premises being the same conveyed to the mortgagor by T. A. Roe by deed dated April 30th 1946, yet to be recorded.
