MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Eva Frances Weeks

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns: "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the East side of Fifth Avenue, being known and designated as Lot No. 50, as shown on Plat of Section 2 of Judson Mills Village, made by Dalton and Neves, Engrs., in November, 1939, which Plat is recorded in the R. M. C. Office for Greenville County in Plat Book K at Page 25, and having, according to said Plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the Southeast corner of the intersection of Fifth Avenue and Fifth Street, and running thence with the South side of Fifth Street, S. 83-53 E. 123.3 feet to an iron pin on said Street; thence with the rear line of Lot No. 35, S. 6-07 W. 80 feet to an iron pin on the East side of Fifth Avenue; thence with the east side of Fifth Avenue N. 6-07 E. 80 feet to the beginning corner,

Said premises being the same conveyed to the mortgagor by Lee Weeks by deed of even date to be recorded herewith.
