MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Agnes Davis McMahan
.....(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northwestern side of North Franklin Road, and being shown as lots Nos. 223 and 224 on plat of the property of Colonia Company, made by Dalton & Neves in Feb. 1938, recorded in the RMC Office for Greenville County in Plat Book "J" at pages 4 and 5, and having according to said plat the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the Northwestern side of North Franklin road, at joint corner of lots 222 and 223 and running thence with the line of lot No. 222 N. 57-32 W. 200 feet to an iron pin, rear corner of lot 416 ; thence with the rear line of lots 416 and 415 N. 32-58 E. 142.8 feet to an iron pin, corner of lot No. 225 ; thence with the line of lot No. 225 S. 57-02 E. 200 feet to an iron pin on North Franklin road; thence with the Northwestern side of said road S. 32-58 W. 141 feet to the point of beginning.
