----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of ~~Twenty-Eight Hundred Fifty and No/100~~ DOLLARS (\$ ~~2,850.00~~), with interest thereon from date at the rate of ~~four (4%)~~ per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, and on the East side of Fourth Avenue in Section 2 of Judson Mills Village, being known and designated as Lot No. 17 as shown on a plat of Section No. 2 of Judson Mills Village made by Dalton and Neves, Engineers, in November 1939, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book K at Page 25, and having, according to said plat, the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the East side of Fourth Avenue, joint corner of Lots Nos. 17 and 18, said pin being 400 feet South from the Southeast corner of the intersection of Fourth Avenue and running thence with the line of Lot No. 18 S. 33-53 E. 122 feet to and Sixth Street, to an iron pin; thence with the rear line of Lot No. 16, S. 6-07 W. 73 North side of said alley N. 80-35 W. 122.2 feet to an iron pin on the East side of Fourth Avenue; thence with the East side of Fourth Avenue, N. 6-07 E. 66 feet to the beginning corner."
