TO HAVE AND TO HOLD, all and singular, the said Premises unto the said Mortgagee and his Heirs and Assigns, forever. And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said Mortgagee and his Heirs and Assigns, from and against myself, my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming or to claim same or any part thereof.

And the said Mortgagor s to insure the house and buildings on said lot against loss or damage by fire and windstorm in a sum of not less than Twenty-Five Hundred & No/100 (2500.00) Dollars in a company or companies satisfactory to the Mortgagee; and keep the same insured and assign the policy of insurance to the said Mortgagee; and that in the event that the Mortgagor shall at any time fail to do so, then the said Mortgagee may cause the same to be insured in Mortgagor's name and reimburse himself for the premium and expense of such insurance under this mortgage, with interest.

PROVIDED ALWAYS, NEVERTHELESS, and it is the true intent and meaning of the parties to these Presents, that if the said Mortgagor do and shall well and truly pay or cause to be paid unto the said Mortgagee the debt or sum of money, with interest thereon, if any be due, according to the true intent and meaning of the said note, then this deed of bargain and sale shall cease, determine, and be utterly null and void; otherwise to remain in full force and virtue.
