BEGINNING at an iron pin on the East side of McDaniel Avenue which iron pin is 175 feet North of the Northeastern intersection of McDaniel Avenue and Newman Street, joint corner of Lots #35 and 36 and running thence with the joint line of said lots S. 75-31 E., 170 feet to an iron pin, rear joint corner of said lots, thence N. 14-29 E., 100 feet to an iron pin, rear joint corner of Lots #34 and 35, thence along the joint line of said lots N. 75-31 W., 170 feet to an iron pin in the line of McDaniel Avenue; thence along the Eastern side of McDaniel Avenue, S. 14-29 W. 100 feet to the point of beginning.
