WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the North side of the Bent Bridge Road (Old Harris Road) and being known and designated as a portion of Lot No. 3 as shown on plat of the property of Mrs. B.E. Burns, recorded in R.M.C. Office for Greenville County in Plat Book "G", at page 30, and being more particularly described as follows:-

BEGINNING at an iron pin on the North side of the Bent Bridges Road, joint front corner of Lots No. 3 and 4 and running thence with joint line of said Lots N. 26-15 W. 136 feet to an iron pin, thence N. 78-07 E. 55 feet to an iron pin, joint rear corner of Lots No. 2 and 3, thence along a new line, S. 24-40 E. 138.75 feet to an iron pin on the North side of said road, which pin is 8 feet West of the joint front corner of Lots No. 2 and 3, and running thence with said road S. 82-38 W. 52 feet to the beginning corner.
