MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Mary B. Burdett

----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100 -----

DOLLARS (\$ 5000.00 -----), with interest thereon from date at the rate of five and one-half ----- per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Western side of Tyler Street near the City of Greenville, being shown as Lot No. 7 on plat of Augusta Heights made by Dalton & Neves, in April 1941, recorded in Plat Book "K", at Page 88, and described as follows:

BEGINNING at a stake on the Western side of Tyler Street 66 feet North from Amherst Avenue, at corner of Lot No. 8 and running thence with line of said Lot, S. 62-20 W. 190 feet to a stake; thence N. 26-38 W. 66 feet to a stake at corner of Lot No. 6, thence with line of said lot, N. 62-20 E. 190 feet to a stake on Tyler Street, thence with the Western side of Tyler Street, S. 26-38 E. 66 feet to the beginning corner.
