MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, James W. Foster

(hereinafter referred to as Mortgagor) SEND(S) GREETING:
WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifty-six hundred and no/100 DOLLARS (\$5,600.00), with interest thereon from date at the rate of four (4%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, known and designated as Lots Nos. 3 and 4 according to plat made by Dalton & Neves, April 1946, said Lots are near Paris Station and lie on the East side of the County Road, and having the following metes and bounds:

BEGINNING on East side of County Road corner of Lot No. 2; thence with County Road S. 2-00 W. 160 feet to corner of Lot No. 5 on County Road; thence S. 88-00 E. 180 feet to a five foot strip in rear reserved for utilities; thence with rear line of Lots Nos. 4 and 3 along with side of utility strip N. 2-00 E. 160 feet to rear corner of Lot No. 2; thence with line of Lot No. 2, N. 88-00 W. 180 feet to the beginning corner.
