TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Sara B. Lynch, of Greenville, S. C., SEND GREETINGS:

WHEREAS I, the said Sara B. Lynch

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of EIGHT THOUSAND AND NO/100

(\$ 8,000.00) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of SEVENTY AND NO/100

(\$ 70.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder hereof, be immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fees besides costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage), as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, Sara B. Lynch, the said

E. Dalton, recorded in the R.M.C. Office for Greenville County in Plat Book E, at page 136, and being more particularly described according to a survey and plat of Pickell & Pickell, Engrs., dated Oct. 31, 1944, as follows, to-wit:-

"BEGINNING at an iron pin on the east side of Augusta street at the corner of Lot No. 4, which point is 495.3 feet from the south-east corner of the intersection of Augusta St. and East Prentiss Ave., and running thence along the line of said Lot No. 4, N. 42-07 E. 170.7 feet to an iron pin on an alley; thence along the line of said alley, S. 53-03 E. 25 feet to an iron pin thence still with said alley S. 59-28 E. 35.9 feet to an iron pin at the rear corner of Lot No. 6; thence along the line of that lot, S. 42-07 W. 180.2 feet to the corner of said lot on the east side of Augusta St., thence along the line of said Augusta St., N. 47-53 W. 60 feet to the beginning corner. Being the same lot conveyed to me by J. O. Hughey and Grace Evelyn Hughey by deed of even date herewith, not yet recorded, this mortgage being given to secure the unpaid portion of the purchase price thereof."
