TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Robert A. Fowler and Sarah E. Fowler  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of Beck Avenue, near the City of Greenville, and being known and designated as Lot No. 251 on Plat made by Dalton and Neves, in April 1941, revised in April 1942, recorded in the R.M.C. Office for Greenville County in Plat Book "M" at Page 47, and having, according to said plat, the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the Southern side of Beck Avenue at the joint front corner of Lots Nos. 250 and 251, and running thence with the line of Lot No. 250, S. 0-13 E. 140 feet to an iron pin; thence N. 89-47 E. 60 feet to an iron pin, corner of Lot No. 252; thence with the line of said lot, N. 0-13 W. 140 feet to an iron pin on Beck Avenue; thence with the Southern side of Beck Avenue, S. 89-47 W. 60 feet to the point of beginning."
