MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, W. Frank Durham

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Six Thousand and No 100

DOLLARS (\$ 6,000.00), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, at the intersection of Cureton Street and Mitchell Street, near the City of Greenville, being shown as Lot No. 14 on plat of Kanatenah, and recorded in the R.M.C. Office for Greenville County in Plat Book "F" at Page 131, and being more particularly described by metes and bounds, as follows:

"BEGINNING at an iron pin on the Northern side of Cureton Street at the joint front corner of Lots Nos. 13 and 14, and running thence with the line of Lot No. 13, N. 25-51 W. 155 feet to an iron pin at rear corner of Lot No. 28; thence with the rear lines of Lots Nos. 28 and 29, N. 63-38 E. 120 feet to an iron pin on the Western side of Mitchell Street; thence with the curve of Mitchell Street and Cureton Street in a Southwesterly direction to an iron pin, corner of Lot No. 13, the point of beginning."

Said premises being the same conveyed to the mortgagor by T. E. Durham by deed dated September 28, 1944, recorded in Volume 268 at Page 28.
