"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the Eastern side of First Street (formerly Mellon Street) in the Village of Slater, S. C., and described as follows:

"BEGINNING at an iron pin on the Eastern side of First Street, joint front corner of Lots Nos. 12 and 13 of Block H, and running thence with the line of Lot No. 12, N. 82-41 E. 124 feet to an iron pin, joint rear corner of Lots Nos. 10 and 11 of Block H; thence with the rear line of Lot No. 10, S. 7-24 E. 70 feet to an iron pin, joint corner of Lots Nos. 9, 10, 13 and 14; thence with the line of Lot No. 14, S. 82-41 W. 124 feet to an iron pin on the Eastern side of First Street; thence with First Street, N. 7-24 W. 70 feet to the beginning corner."
