"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, at the Northwestern corner of the intersection of Young Street and Brockman Avenue in the subdivision known as San Souci Villa, and having according to plat recorded in Plat Book "C" at page 131, the following metes and bounds, to-wit:-

BEGINNING at an iron pin at the Northwest corner of the intersection of Young Street and Brockman Avenue, and running thence with the Western side of Brockman Avenue, N. 10-30 E. 65 feet to an iron pin; thence N. 57-25 W. 166.8 feet to an iron pin; thence S. 12 W. 64 feet to an iron pin on Northern side of Young Street; thence with the Northern side of Young Street S. 57-25 E. 170 feet to the point of beginning.
