"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, on the Southwestern side of Orlando Avenue, known and designated as lot No. 80 on plat of Paris-Piney Park, recorded in the R.M.C. Office for Greenville County in Plat Book "H" at Page 19, and having, according to said Plat, the following metes and bounds, to-wit:-
