MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Roy E. Henderson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighteen Hundred and No/100

DOLLARS (\$ 1800.00), with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the West side of Lindburg Street in the Village of Slater, S.C. and being known and designated as Lot #12 of Block D as shown on plat thereof recorded in Plat

Book K at Page 64 and being more particularly described, according to said plat, as follows:

BEGINNING at an iron pin on the West side of Lindburg Street, joint front corner of lots #11 and 12 of Block D and running thence with line of lot #11, N. 51-20 W. 110 feet to an iron pin in the rear line of lot #20; thence with rear line of lots #19 and 20, N. 38-40 E. 70 feet to an iron pin, rear corner of lots #12 and 13; thence with line of lot #13, S. 51-20 E. 110 feet to an iron pin on West side of Lindburg Street; thence with Lindburg Street, S. 38-40 W. 70 feet to the beginning corner; being the same premises conveyed to the mortgagor herein by Robert J. Sizemore by deed dated 23rd October, 1942, recorded in Volume 248 at page 198.
