WHEREAS: I, Robert L. Moore of Greenville, S. C. hereinafter called the Mortgagor, is indebted to Fidelity Federal Savings & Loan Association, a corporation organized and existing under the laws of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Twenty-Three Hundred and No/100 Dollars (\$ 2300.00), with interest from date at the rate of Four per centum (4 %) per annum until paid, said principal and interest being payable at the office of Fidelity Federal Savings & Loan Association in Greenville, S. NOW, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, in Greenville Township, State of South Carolina; on the East side of Wright Street, near the City of Greenville, being shown as lot #25 on Plat of Property of J. P. Goodwin made by W. A. Hudson January 20, 1905, recorded in Book of Deeds NNN at Page 485 and described as follows:

BEGINNING at a stake on the East side of Wright Street at corner of lot 26, and running thence with line of said lot, N. 59-15 E. 193 feet to a stake on Church Street; thence with the West side of Church Street, S. 21-20 E. 70 feet to a stake at corner of lot #24; thence with line of said lot, S. 59-15 W. 193 feet to a stake on Wright Street; thence with the East side of Wright Street, N. 21-20 W. 70 feet to the beginning corner. Being the same property Conveyed to the mortgagor herein by Minnie L. Garrett, et al by deed recorded herewith.
