"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, near the City of Greenville, and being known and designated as Lot 33-C of a subdivision known as "Morgan Hills" as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book A, at page 69, and having the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the North side of Morgan Street at joint corner of Lots 33-C and 33-D, and running thence along the line of said Morgan Street N. 82 1/2 E. 60 feet to an iron pin; thence N. 7 1/2 W. 200 feet to iron pin; thence S. 82 1/2 W. 60 feet to iron pin, joint rear corner of Lots 33-C and 33-D; thence with joint line of said lots S. 7 1/2 E. 200 feet to the beginning corner.
