PROVIDED ALWAYS, nevertheless, and that it is the true intent and meaning of the parties to these Presents, that if X, the said mortgagor

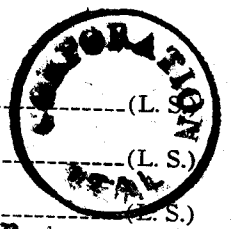
