MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, John W. Hewell and Nelle M. Hewell

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Butler Avenue, in the City of Greenville, and described as follows
