"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, just outside the City of Greenville, being shown as Lot No.2,

Block E. of the O.P.Mills Subdivision, and having, according to a Plat thereof made by C. M. Furman, Jr., October 1931, the following metes and bounds, to-wit:-

"BEGINNING at a point, the ~~Northwestern~~ intersection of Prentiss Avenue and Elm Street and running thence with Elm Street ~~N. 45-33~~ W. 180 feet to a point on the South side of a 16-foot alley; thence with said alley, S. 45-27 W. 66 feet to a point; thence S. 44-33 E. 180 feet to a point on the Northwest side of Prentiss Avenue; thence with said Avenue, N. 45-27 E. 66 feet to the point of beginning."
