SEND GREETING:

Whereas, I the said Annie T. Lindsey

in and by my certain Promissory note in writing, of even date with these presents, am well and truly indebted to R. J. Poole

in the full and just sum of Eight Hundred and No/100 (\$800.00) Dollars, to be paid Sixty (60) Days after date

with interest thereon from maturity at the rate of six (6%) per cent. per annum, to be computed and paid monthly

County, State aforesaid, known and designated as lot # 15 of Block D on Plat of Kanateenah, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book "F" at Pages 131 and 132, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an point on the Southern side of Stewart Street, joint front corner of lots # 15 and 16, and running thence S. 26-30 E. 165 feet to pin; thence S. 63-35 W. 60 feet to iron pin, corner of lot # 14; thence with line of lot # 14, N. 26-30 W. 165 feet to pin on the Southern side of Stewart Street; thence along the Southern side of Stewart Street, N. 63-35 E. 60 feet to the point of beginning.
