Whereas, I- - - - - the said Lydia McAlister Christman- - - - -

in and by my- - - - - certain Promissory, note in writing, of even date with these presents, am- - - - - well and truly indebted to The First National Bank of Greenville, S.C., as Trustee for the Estate of H.C. Hagood- - - - - in the full and just sum of Thirty-one Hundred and No/100 (\$3100.00)- - - - - to be paid on or before three years after date- - - - -

NOW, KNOW ALL MEN, That the said Mortgagor- - - in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee- - - according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to the said Mortgagor- - - in hand well and truly paid by the said Mortgagee- - -, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain and release unto the said Mortgagee - - -, and its successors ~~Heirs~~ and Assigns forever, all and singular that certain piece, parcel, lot or tract of land situate, lying and being in Greenville Township, Greenville- - - - -County, State aforesaid, on the Northeastern side of Court Square and being known and designated as the Palmetto Building and being more particularly described as follows:

BEGINNING at a stake at the corner of Court Street and Court Square and running thence with said Court Square, N. 17 1/2 E. 53 feet, 4 inches to line of property formerly owned by F.Hahn, and including one-half of the brick wall of said premises, and running thence with the center of said wall - formerly Hahn's line - 50 feet; thence with the line of the property formerly owned by Hahn, N. 17 1/2 E. 10 inches; thence continuing with the line of property formerly owned by Hahn, S. 72 1/2 E. 50 feet to a 16-foot alley; thence with said alley, S. 17 1/2 W. 54 feet, 2 inches to Court Street; thence with said Court Street, 100 feet to the beginning corner.
