am well and truly indebted to

Dollars, in and by my certain promissory note in writing of even date herewith, due and payable

at the rate of One hundred (\$100.00) Dollars per month, beginning thirty days from the date hereof, and a like amount each successive thirty days until paid in full. in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Glyde Glenn, his heirs and assigns,

all that tract or lot of land in

Greenville Township, Greenville County, State of South Carolina, in the Town of West Greenville, situate at the northwest intersection of Endel and Gower Streets and being known and designated as Lots 4, 5, 6, 7, and 9 according to a plat made by R. E. Dalton, Engineer, in May, 1924, and recorded in the office of the Register of Mesne Conveyance for Greenville County in Plat Book F, Page 230, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the north side of Endel Street at the southeast corner of an 8-foot alley and running thence along the north side of Endel Street N. 58-40 E. 120.8 feet to a point at the northwest intersection of Endel and Gower Streets; thence along the west side of Gower Street N. 58-20 W. 168.4 feet to a point in the corner of lot No. 10; thence along the line of lot No. 10, S. 58-40 W. 84.9 feet to a point in the line of lot No. 11; thence along the line of lot No. 11, S. 31-27 E. 30 feet to a point in the line of lot No. 8; thence along the line of lot No. 8, N. 58-40 E. 42.5 feet to a point at the rear corner of lot No. 7; thence along the rear line of lot No. 7 and the western line of lot No. 4, which is also the eastern line of the 8-foot alley above referred to, 120 feet to the north side of Endel Street, the beginning corner.
